

Loss of the Employee Rate: If you are eligible for the Employee Rate Program, you will receive a 14.24% variable APR on purchases and balance transfers. In the event your current employment ends, we will apply the APR then in effect which would apply when the Introductory APR expires, based on your creditworthiness.

Billing Rights: Information on your rights to dispute transactions and how to exercise those rights will be provided in your Cardholder Agreement.

Important Information About Procedures for Opening a New Account
