

How We Will Calculate Your Balance: We use a method called "Average Daily Balance (including new transactions)."

Loss of the Introductory APR: If you make a late payment, we may end your Introductory APR for Purchases and Balance Transfers and apply the Purchase and Balance Transfer APR which would apply when the Introductory APR expires.

Loss of the Employee Rate: If you are eligible for the Employee Rate Program, you will receive a 15.24% variable APR on purchases and balance transfers. In the event your current employment ends, we will apply the APR then in effect which would apply when the Introductory APR expires, based on your creditworthiness.
